## **Production Risk Profiler**

Completing this generic guide aids in identifying and communicating safety hazards, risks and controls for the safety of people attending, performing in or working on productions at Manning Entertainment Centre including the different phases of bump in, performance, and bump out.

The Work Health and Safety Act 2011 and Regulations require anyone in control of a production activity (a workplace) to consult with the stakeholders, identify the potential hazards of the proposed activities to assess the risks involved, develop controls to eliminate or minimise the risks, communicate them to all at-risk stakeholders, and to monitor the effectiveness of those controls. Some activities are strictly regulated by WorkCover. Under the Act, all stakeholders including the Licensee, Performers, Contractors, Staff and Volunteers have a duty of care to identify and warn people about risks relating to the production.

All production activities must be conducted in accordance with the relevant Legislation, Statutory Regulation, and Australian Standards. Manning Entertainment Centre considers the Safety Guidelines released by MEAA, AEIA and the Australian Film and Television Industries as the minimum acceptable production safety guidelines for activities not strictly regulated by WorkCover. Nothing in this guide shall relax or contravene any provision of any Standard, Act or Regulation. This generic guide may not cover all hazards, hazards that coexist, hazards that may evolve due to a lack of or effectiveness of controls, controls operating in isolation or hazards outside of the control of Manning Entertainment Centre.
